LOVERS OF DEMOCRACY

In a recent issue of Current Religious thought, Herbert H. Lehman presented ten axioms for lovers of democracy. These are important in that the same line of thought is passing through the minds of many people, particularly those whose skin is of a darker hue.

"1) Democracy as a political system is an effective expression of the moral and religious principle that all men are alike--the children and creatures of the living God; and that an infringement of the fundamental rights or duties of men is a violation of the law of God.

"2) We give aid and comfort to the enemies of democracy when we harbor or spread unjust suspicion against our neighbors, founded on differences in religion, in color, in social standing, or ethnic origin.

"7) We give aid and comfort to the enemies of democracy when either as individuals or an organized groups we prevent our fellow-citizens of different backgrounds from enjoying the rights of Americans to labor, to equal economic opportunity in every field, to decent living

conditions, to adequate provision for the moral and spiritual development of their children, and to free association with their fellow men as equals under the law and as equals in the sight of God."

GOOD NEWS FOR RELOCATION CENTERS

By reporting that 53% of the people polled in Washington, Oregon, Arizona, Nevada, and California, favor the return of citizens of Japanese ancestry to their former homes, the Gallup Poll (American Institute of Public Opinion) induced extensive editorial comment in the West Coast journals.

The Seattle Times on December 30 noted... "preponderant opinion indicated by this first poll is exonerative, not to say lenient; certainly less harsh than might have been expected." However, the writer proceeded with reservations as he said... "It was unlikely that

the people of this area will reach final conclusions until the war is ended."

Though surveys of the Gallup Poll variety leave many questions unanswered, they nevertheless do indicate trends in the country's public opinion. One wonders if voters were aware of the implications of their "Ayes" when they said they were in "Favor" of the return of citizens but opposed to "hiring those of Japanese ancestry and opposed to their operating stores."

Following are percentages as tabulated...

Results of Poll in Five Western States

Would permit <u>all</u> of Japanese ancestry to return -	29%
Would allow <u>only</u> citizens to return - - - - -	24%
Would allow <u>none</u> to return - - - - -	31%
Undecided on question - - - - -	16%
Would <u>hire</u> those of Japanese ancestry - - - - -	24%
Opposed to hiring those of Japanese ancestry - - -	60%
Would trade at stores operated by Japanese - - - -	38%
Opposed to trading at such stores - - - - -	58%

Nation Wide Verdict

Would permit <u>all</u> to return - - - - -	35%
Would allow <u>only</u> citizens to return - - - - -	26%
Would allow <u>none</u> to return - - - - -	17%
Undecided on question - - - - -	22%

"Think so?" said the minister innocently. "Then why don't you give it the spread that it deserves?"

"Believe me, I will! And say, if you come across another Christian like that send him to see me."

What Really Caused The Evacuation?

California Joint Immigration Committee which is composed of American Legion of State of California, State Federation of Labor, Native Sons of the Golden West, California State Grange, were largely instrumental in passing the 1913 Alien Land Act, and the 1924 Immigration Law which excludes any Asiatics from a quota.

The Pearl Harbor incident gave them the opportunity to accomplish what they had been unable to achieve in peace time, for according to Chairman Tolan, "The reason for that Executive Order (President's Proclamation) is that the representatives of California, Oregon, and Washington met almost daily back there and we finally evolved this recommendation that the President outlined in his executive order.
